What can Zetas do to bring awareness to hazing and enforce Zeta Phi Beta Sorority, Incorporated's policy against hazing?

- Host an activity such as a workshop, seminar, or program as a chapter or in conjunction with Phi Beta Sigma Fraternity, Incorporated or other like-minded organizations denouncing hazing in any form. Bring in speakers or a panel of qualified experts to address the topic of hazing and work being done to eradicate hazing on your campus, local chapter (graduate and undergraduate), etc.
- Utilize the resources found on the FWDH Website (phiabeta2020.org/finerwomenadont haze) and at National Hazing Prevention (hazingprevention.org) to conduct activities that address anti-hazing. Also, check out the National Pan-Hellenic Council (NPHC) to see what recent work is being done and how the Divine Nine are working together to address this topic.
- Accentuate the positive! Promote, highlight and recognize those events and behaviors that denote the positive aspects of individuals, chapters or organizations.
- View local and state laws on hazing. They differ from state-to-state. Also, contact your legislator concerning federal legislation that may be on the horizon or pending. Currently, there is not a federal statute/law on hazing.
- Review the Disciplinary Policies, Anti-Hazing Policy, and Risk Management Guidelines at the beginning of each fiscal year for Zeta Phi Beta Sorority, Incorporated and before each Membership Intake (graduate and undergraduate).

It is our pleasure to inform you of scheduled events to commemorate the Founder, unique to the Southeastern Region of Zeta Phi Beta Sorority, Incorporated.

The commemoration is a four-phased project. The first phase is the dedication of a museum shadow box display in Founder Watts' birth town of Perry, Georgia. This will occur on September 30, 2017, and is coordinated by Georgia's State Director, Soror Shaneesa Ashford. The invitation and registration for this event is already out.

Phases two through four will occur as precursors to the 83rd Southeastern Regional Leadership Conference; held November 9 – 12, 2017, Hilton Head Marriott Resort and Spa, One Hotel Circle, Hilton Head, SC. Set to occur on November 8, 2017, these phases consist of the unveiling of historical markers on the campus of Savannah State University, and the city of Savannah.

Individuals interested in attending the event or staying over for the Leadership Conference, may make reservations at the Hilton Head Marriott resort and Spa, 843-686-8400.

Founder Watts, was born in Perry, Georgia to Attorney Foster Pettie and Fannie Pettie. She attended public schools in Savannah, Georgia and continued her formal training at Georgia State College, now known as Savannah State University. She later graduated from Howard University with a Bachelor of Arts in Education.

As many of our sister regions have done, the Southeastern Region, its state Directors, Executive Board, and membership are marking their Journey to Centennial with events to honor its birth founder. However, the journey and events, would not be complete without providing an opportunity for chapters, states, and regions to be identified on the historical markers.

RISK MANAGEMENT MOMENT: "Zeta First? Tips for Legal Agreements"

In the third installment of Risk Management moments, I provided tips to mitigate the liability exposure that can result from when negotiating contracts via email. Below please find reminders for reference when entering into contracts.

No Region, State or Chapter shall enter into a contract or financial agreements using the name "Zeta Phi Beta Sorority, Incorporated". When doing business with another entity, the name of the Region, State or Chapter goes first to avoid confusion with the national organization. This includes, but is not limited to, leases, contracts, hold harmless agreements, liability releases, account agreements, purchase orders, and hotel or banquet contracts.

Only the International Grand Basileus and Chair of the National Executive Board can execute contracts on behalf of Zeta Phi Beta Sorority, Incorporated!

When reviewing contracts presented, please take special note of the following provisions:

- Deposits - note the proposed deposit schedule and renegotiate if necessary
- Payment Schedule - pay attention to when the final payment is due and make sure that the members are aware so that they submit ticket sale proceeds in a timely fashion
- Set-up time - be sure that the contract allows time for set up before the start time of the event
- Taxes and gratuities - be sure to consider these obligations when setting your price
- AV Fees - Need a screen, LCD, microphone, etc.? Understand all fees associated with these items and determine whether the use of outside equipment is permitted and more cost effective
- Parking - It is best to advise your guests in advance of any parking fees
- Schedule multiple year deals - committing to multiple years allows you to lock in a price
- Cancellation periods and fees - be mindful of the fees for cancellation, which increase as the event approaches
- Indemnification/Hold Harmless language - this language is usually broadly drafted in favor of the venue. Be sure that these obligations are limited to losses caused by the chapter/State/Region

- Buffet vs. Plated Meals - Think buffet is cheaper? Not always!!
- Insurance - Check the contract language for an obligation to provide a Certificate of Insurance or name the venue as an additional insured
- And again, when contracting, Chapter/State/Region First - Zeta Second
